1. Registration fees

Accepted credit cards for online payment include Visa and Mastercard.

All registration fees must be paid prior to arrival at the conference venue. If the payment has not been received by Agenda Pacific Pty before the conference, the delegate is required to buy his/her tickets through Eventbrite at the registration desk in order to gain entrance to the conference at St Michael Golf Club Jennifer St, Little Bay NSW 2036.

Participants are advised to have a copy of their payment slip or invoice when going to the registration desk at the conference just in case they are requested to show proof of the payment on their arrival.

2. Changes policy

Requests for name substitution made by a registered delegate will be accepted with AUD50 fees (including GST)

All requests have to be made in writing by email to clementine@communicationhearts.com at least 5 days prior the event. No substitution would be made after this deadline.

3. Cancellation and refunds policy

4. Conditions of entry and during the conference regarding COVID-19

- at all times, maintain social distancing measures (as per the NSW Health guidelines) with respect to other visitors and staff;

- stay in your dedicated seat and respect the maximum capacity in all rooms, including balcony
